Sunday dawned bright and sunny - a gorgeous day for our Annual Meeting. Unfortunately - or perhaps fortunately as it turned out - the church heating had failed, so we moved

our combined 9.30am service to Mills Hall. It was packed, with parishioners gathered around tables and children on the floor or on laps. Following morning tea hosted by the Vestry, we moved into our Annual Meeting. After the reports (copies available from the office), which included hearing of our improved financial status in 2009 compared with prior years, and reception of a budget with a small deficit, Debbie LaMano, Les Bengston, and Colette Tarantino, were elected to Vestry and Chris Mauro to the office of Warden. Two items of other business were introduced: the plan for a community garden in our grounds, with food grown going to support the food pantry, and a discussion of the use of our flags in the church.

I raised this latter issue in response to concerns expressed to me by three parishioners about the movement of the flags from immediately behind the altar to the balcony. I presented a history of flags in the church, some basic principles, and four options for their placement (copy below). A number of parishioners spoke, of a range of ages and including both veterans and non-

veterans. The consensus was that option 2 should be adopted. A parishioner has offered to donate new flags, and the existing flags will be placed in Mills Hall, where until now we have had no flags. The discussion was thoughtful and respectful - a model of how to deal healthily with difficult issues!

FLAGS IN CHURCH

History:

1850s? American flags not used in churches

Mid-late 19th century American flags introduced into Roman Catholic Churches to counter criticism that they owe allegiance to the Pope, a foreign power

1940s American flags introduced into churches during WW2

1950s Flags were suspended from angled brackets overhead the nave. Morning Prayer was the primary form of worship in our church, and the liturgical focus was on the Rector and choir.

1970s? With the introduction of the Eucharist as the principal weekly service, the focus of worship moved to the altar.

1970s/80s The altar was moved forward to the front of the sanctuary, with the choir behind. The focus of worship moved to the altar, which was closer to the people. The priest was joined by the Eucharistic Ministers behind the altar.

Exodus 20: 2-3

I am the Lord your God, who brought you out of the land of Egypt, out of the house of slavery; you shall have no other gods before me.

US Code Title 4, Chapter 1, §7k

"When displayed from a staff in a church or public auditorium, the flag of the United States of America should hold the position of superior prominence, in advance of the audience, and in the position of honor at the clergyman's or speaker's right as he faces the audience. Any other flag so displayed should be placed on the left of the clergyman or speaker or to the right of the audience."

1970s-90s At some point the flags were moved from overhead to the back corners of the sanctuary, where they formed a backdrop.

Late 1990s The altar was returned to the back of the sanctuary. Shelves were installed in the back corners of the sanctuary. The flags were moved inwards to stand behind the altar. The priest stood alone at the altar.

2007 Parishioners requested that the Eucharistic Ministers rejoin the priest behind the altar. The flags were obscured, and drew focus from the symbols of our worship. At the end of that year, the flags were moved to the balcony, where they can be seen leaving the church. This follows the traditions of cathedrals, where they are traditionally suspended horizontally overhead, and many churches, where they are placed by the exit as a visible sign of the world into which we go, "rejoicing in the power of the Spirit."

Late 2008 Two parishioners expressed concern to the Rector about the position of the flags.

2009 The vestry discussed the flags and decided that hanging from the bar with the parish banner might be an appropriate position. Nothing was done. Discussion apparently continued among parishioners, though only one person talked with the Rector. The vestry discussed it again. The Rector decided it would be healthiest to have a public discussion at the Annual Meeting.

Principles:

- The architecture always wins!
- In any Christian church, the cross is in the position of honor, representing God on whom our worship is focused. This means that the US Flag Code is by definition violated any time an American flag is in church, because the cross is always of highest prominence.
- The symbols of the core of our worship, Word and Sacrament, that is, the pulpit, altar and font, should not be obscured or overshadowed.
- The Rector is responsible for worship and for the use and control of the church and its furnishings and appurtenances

The flag is important to many people in this congregation. Therefore we are looking at options that do least injustice to the flag code while still observing the first commandment, and being practical, given our architecture.

Some options:

1. Move the altar forward to where it was in the 1980s and 1990s. The shelves would be removed, the tabernacle placed on a side table, and the flags replaced in the back corners. The choir would be placed behind the altar.
2. Suspend the flags above the congregation, immediately in front of the balcony, in line

with our St James banner, so that they are highly visible when leaving the church.

3. Place the flags in wall brackets, similar to their placement under Mr Mills.

4. Place the flags on the floor by the font and pulpit, or both by the font; move the font to either the center of the aisle (visually uniting the sacraments of Baptism and Eucharist) or in the back of the church, removing one or more pews to make space (the traditional placement of the font, in the entry of the church)

WARDEN'S REPORT

I welcome Chris Mauro to the position of Warden, Colette Tarantino and Les Bengtson to the Vestry, and congratulate Debbie LaMano on her re-election. I look forward to working with them and the rest of the Vestry, and am thankful for their commitment to St. James.

Please plan on joining us in fellowship and in support of our youth as they prepare and serve us at the Shrove Tuesday Pancake Supper.

I am looking forward to reading C.S. Lewis' *Mere Christianity* and participating in the Book Group meeting on Wednesday nights during Lent. I encourage you to join in.

Are you interested in the history of our church? Do you love to search through old documents? Have you ever wanted to be an archivist? A St. James History Committee is being formed to search through boxes of material that have been found in a storage room. This material needs to be organized and stored properly so that it will be available for future generations. We also plan to catalog and photograph church items. We already have one volunteer – Marty

Scott. Please let me know if you are willing to assist. We are not going to be able to do this quickly, but will work on one project at a time. We will probably meet at least once a month – however, you would not have to attend every time.

Looking into the future, we are creating a sub-committee of the Buildings and Grounds Committee to begin making plans to restore Mills Hall. Although this project is over a year away, we need to carefully look at our needs so that correct decisions are made. If you are interested in having your ideas heard contact Kurt Rettig (chairman of Building & Grounds Committee) to volunteer.
